**I declare to be aware that**

Natural areas present hazards, such as flash floods, thermal shock, drowning, slippery rocks, venomous animals, among others. The visitor is the main responsible for its own safety.

It is only allowed to camp at the campsites located near the mountain shelters at Pedra do Sino and Pedra do Açú.

**It is forbidden:**

- a) To come in and out of the park using any entrance different than the official ones;
- b) The presence of domestic animals within the park;
- c) To shout or produce noise of any kind that may disturb the local fauna;
- d) To light fires;
- e) To litter trails, camping sites or any other area of the park. All the garbage produced by visitors shall be collected by them, and discarded in appropriate places.
- f) To carry any kind of gun, including firearms, large knives, and the like;
- g) To collect plants, flowers or seeds;
- h) To mark names, dates or any other signs in rocks, trees, signs or buildings;
- i) To use shortcuts or interdicted areas;
- j) To hunt, capture or disturb wild animals;
- k) To fail to present the ticket or document that authorizes the permanence in the park, when asked by Park staff;
- l) To deny to identify yourself, when asked by Park staff;
- m) To drink alcohol or other drugs. Park employees have the authority to intervene in necessary cases;
- n) To enter with glass bottles;
- o) To refuse to pay owned fees.

**I also declare to be aware:** I - of the fact that I am responsible for the actions of my group, II – that if I wish to stay for a period of time longer than that for which I paid for, I must get such authorization by Park staff, and I must pay the corresponding difference when I check out, III – that I must check this declaration out when I leave the park

THE NON-OBSERVANCE OF THE ABOVE RULES WILL LEAD TO THE PENALTY OF FINES OF AT LEAST R\$ 500,00, ACCORDING TO BRAZILIAN LAW (DECRETO 6.514, DE 22 DE JULHO DE 2008).
